## To prohibit aid that will benefit Hamas, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Stop Support for5 Hamas Act of 2023".

#### 6 SEC. 2. UNITED STATES CONTRIBUTIONS TO UNRWA.

7 The United States may not make any voluntary or
8 involuntary contributions to the United Nations Relief and
9 Works Agency for Palestine Refugees in the Near East
10 (referred to in this Act as "UNRWA"), to any successor

5 (a) IN GENERAL.—None of the amounts appropriated under the heading ECONOMIC SUPPORT FUND in 6 7 any Act making appropriations for the Department of 8 State, foreign operations, and related programs may be 9 obligated or expended to provide assistance to the West 10 Bank and Gaza until the Secretary of State certifies to Congress that on or after October 7, 2023, the Israeli De-11 12 fense Force has verifiably dismantled the terrorist infra-13 structure of Hamas, and other terrorist groups located in 14 Gaza.

(b) COMPTROLLER GENERAL REVIEW OF CERTIFI(cation.—Not later than 90 days after the Secretary of
State makes a certification under subsection (a), the
Comptroller General of the United States shall submit to
Congress an assessment of whether the Israeli Defense
Force has verifiably dismantled the terrorist infrastructure of Hamas, and other terrorist groups located in Gaza.
